## Invitation for Bids

1. Aandikhola Gaunpalika invites sealed bids or electronic bids from eligible bidders for the **Upgrading of Aahal Barpippl Chisakhola Rural Road from CH 0+000 to CH 0+750** in the Contract Package as shown below under National Competitive Bidding procedures.
2. Interested Eligible Bidders may obtain further information and inspect the Bidding Documents at the **Office of Rural Municipal Executive, Aandikhola Gaunpalika, Krishi, Setidovan, Syangja, website: www.aandikhola.gov.np** or may visit PPMO website <http://www.boipatra.gov.np/egp>.
3. Detail of Qualification requirements including minimum required average annual construction turnover, experience in similar nature of works, minimum number of essential equipment, qualification and experience of key site manager and technical personnel, minimum of liquid asset and/or credit facilities as specified in bidding document.
4. Bidding will be conducted through National Competitive Bidding (NCB) procedures (Model Bidding Document as per Electronic Government Procurement issued by PPMO). This is open to all bidders from Eligible Source Countries as defined in the Bidding Documents. A margin of preference shall not apply.

5. To qualify for award of contract, eligible Bidders must meet the following key qualifications and other qualification specified in bidding documents:  
**Minimum Average Annual Construction Turnover of the best three (3) years within the last five (5) years: NRs 15,000,000.00**  
**Minimum Work experience of similar size and nature: at least 1 (One) road construction with a value of at least NRs 8,000,000.00 within the last Five (5) years.**
6. A complete set of bidding documents in English may be purchased by the interested bidders upon submission of a written application to the **Office of Rural Municipal Executive, Aandikhola Gaunpalika, Krishi, Syangja** and upon payment of a non-refundable fee as shown in the above table. Bidding documents can be purchased during office hours till **07-February-2019** from **Office of Rural Municipal Executive, Aandikhola Gaunpalika, Krishi, Syangja**.
7. For the purpose of Bidders who choose to submit their bid electronically through E-procurement section of PPMO Web Site <http://www.boipatra.gov.np/egp> the Bidders may either purchase the hard copy of bidding documents or may choose to download the bidding documents, prepare their bids and submit the electronic bids as specified in the instructions to Bidders. In case the Bidder chooses to download and submit bid electronically, the bidder shall be required to deposit the cost of bidding document (as specified in the table above) in the Employer's Rajasw (revenue) account as specified below and scanned copy (PDF format) of the Bank deposit voucher shall also be submitted along with the electronic submission of the bid files.

8. Pre-bid meeting will be held at **Office of Rural Municipal Executive, Aandikhola Gaunpalika, Krishi, Syangja** on 11:00 hrs of **24-January-2019**.
9. Sealed or electronic bids must be submitted to the **Office of Rural Municipal Executive, Aandikhola Gaunpalika, Setidovan, Krishi, Syangja** by hand or through PPMO website <http://www.boipatra.gov.np/egp> on or before **12:00 hr of 08-February-2019**. Late bids will be rejected and not opened. The bids will be opened physically and electronically at **13:00 hours 08-February-2019** in the presence of the bidders' representatives who choose to attend at **Office of Rural Municipal Executive, Aandikhola Gaunpalika, Krishi, Syangja**.
10. All bids shall be accompanied by a Bid Security for the amount as specified in the table above in local currency. The bid security guarantee shall conform to the standard format as specified in the bid document. The bid security guarantee issued only by the commercial bank approved by Nepal Rastra Bank shall be accepted by the Employer.
11. Bidders are required to specify the total price of the Bid in the Letter of Bid or the Bid Price in the Bill of Quantities. Failure to specify the total price of the Bid in the Letter of Bid or the Bill of Quantities shall be ground for declaring the bid non responsive.
12. Bids shall be valid for the period as mentioned in the table above after the deadline for Bid submission and Bid security shall be valid up to the period as mentioned in the table above. **Office of Rural Municipal Executive, Aandikhola Gaunpalika, Krishi, Syangja** reserves right to accept or reject any or all bids or annul the bidding process and reject all bids without assigning any reason, whatsoever.
13. If the last date of purchasing and /or submission falls on a government holiday, then the same time on next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
14. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
